

**DE BORTOLI ‘Win a De Bortoli Woodfired Fire Pit’ PROMOTION**

**TERMS AND  
CONDITIONS**

1. Information on how to enter the prize(s) form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. Entry is only open to Australian residents aged 18 years or over. Employees (and their immediate families) of the Promoter, participating off-premise outlets and agencies associated with this promotion are ineligible to enter.
